Change Patio 2 Worm Eaten Pitch limitation from "not limited" to "not permitted"	
Rational: (<i>Briefly explain why the proposal should be adop</i>	ted?)

<u>Worm-Eaten Pitch in Patio 1 and Patio 2 Decking</u> is defined as "not permitted" Patio 1 and "not limited" in Patio 2. This occurrence appears to be a typo. We decided to include all characteristics that were not mentioned in the rule for clarity. Those not being mentioned in the rule were considered "not permitted." Therefore, the wording in Patio 1 is correct, while that in Patio 2 is incorrect. Worm-Eaten Pitch does not appear in the WWPA Patio Rules as it is not found in Western Species. In the past, all SPIB adaptations to the WWPA Patio grades were noted in brackets.

a. We did away with the brackets found in the 2014 version by stating the following:

430. PATIO DECKING

Some mills manufacture decking under Western Wood Products Association (WWPA) Rules. The Southern Pine Inspection Bureau has provided a guideline below for applying these rules to Southern Yellow Pine lumber. For a complete set please contact WWPA. There are two grades of Patio Decking: PATIO 1 and PATIO 2. Patio Decking is available in nominal 1-1/4" thickness surfaced dry either 1" or 1-5/32" (29mm) thick, and 5-1/2" (140mm) wide. One inch thick stock is manufactured with ½" radius edges. Stock 1-5/32" thick has 3/8" radius edges. Standard lengths are 6' and longer in multiples of 1'.
